

# **NUCLEAR STRESS TEST INSTRUCTIONS**

**IMPORTANT**: Please <u>CAREFULLY</u> read and comply with all instructions in order to avoid rescheduling. (Check with your cardiologist regarding all medication)

## **24 HOURS BEFORE YOUR TEST**

- NO coffee or tea of any kind
- NO decaffeinated coffee, tea of any kind, including herbal tea
- NO colas or soft drinks including those labeled caffeine free
- NO chocolate (candy, cakes, pies, cocoa, white chocolate, etc.)
- NO Anacin, Excedrin, or any other aspirin products containing caffeine
- NO Theophylline type medications
- NO smoking, all vaping, etc.
- NO beta blockers or calcium channel blockers (unless otherwise instructed by your physician)

### THE DAY OF THE TEST

- Nothing to eat or drink **4 HOURS** before the test. You **MAY** drink water in any amount.
- Please wash chest area and avoid any oil, lotion, powder, and perfumes.
- Wear comfortable shoes and clothes for exercising on a treadmill (laced athletic shoes). Avoid wearing
  dresses or one-piece jumpsuits. NOTE: Exam area tends to be cold. You may want to bring a sweater or
  blanket.
- Bring a current list of medication and dosages.
- If you are diabetic, please talk to your ordering physician about restrictions.
- Bring a small snack (high fat) and water to your appointment to be eaten between the exercise stress
  and imaging procedure. Examples include bagel and cream cheese, peanut butter crackers, shake or
  anything that contains high fat.
- Bring your scheduled cardiac medication with you, to take as directed by the technician after the test.
- If you have asthma, bring your inhaler with you.
- For LEXISCAN ONLY, please bring a caffeinated beverage to drink after the test.



## FOR RADIATION SAFETY REASONS, ONLY PATIENTS ARE PERMITTED IN THE TESTING AREA.

#### **IMPORTANT NOTICES**

\*\*24 HOUR NOTICE is required for all cancellations; you will be charged a cancellation fee and for the cost of the tracer. In the event you fail to follow instructions, your test may be cancelled, and fees applied.

Scans on pregnant patients will not be performed. All female patients who are neither post-menopausal nor surgically sterile will require verification of pregnancy status before appointment time.

If you are going through a secure location, i.e., airports or government buildings, within 72 hours after testing, please inform technologist and he/she will provide you with appropriate documentation.
